Cllrs discussed potential aesthetic works to Bisham Roundabout, suggestion that the planting of shrubs would make a difference to the aspect of the village.

ACTION – BM to discuss with Highways England

JC reported that there had been an issue with the electrics on Marlow Bridge resulting in lighting failures. RBWM have commissioned an independent report on the lighting proposals.

GW followed up the suggestion of Deer Signs on Burchetts Green Road. BM reiterated RBWM's position on "road clutter" and the evidence of need for changing that position. MRB suggested adding Deer Signs to existing posts. GW suggested compiling sufficient evidence of need.

105) Parish land

Stream Clearance

Jeff Woodhouse gave a presentation on the Stream Clearance programme he is running in the area with a group of volunteers. The scheme will improve flow across the whole of Bisham Stream.

JC asked if the project was to create better fishing conditions. JW concurred that the project would create better spawning grounds.

JC asked about the group's expertise. JW stated that the group always worked with the Environment Agency and included a retired EA officer.

JC asked about costs to BPC. JW stated the project had secured 10k funding to cover the manual works required and was in the process of applying for more for continued work.

AK thanked JW for the presentation and proposed looking at a financial contribution to the group during the budget discussion in December. GW seconded. Cllrs agreed.

Other Issues

AK offered to re-erect the Orchard Christmas Lights this year and would need some funding for batteries.

JC reported that there was an active flood alert in the area.

107) Finance

BM gave an update on current financial position, highlighting that the Council had £18,631.76.

AK proposed donating £70 to the Royal British Legion. MRB seconded Cllrs agreed.
