Minutes of the Meeting of the Parish Council held on 25th April 2022 at 7:30pm in Bisham Abbey

Attendees

Public Forum

One Member of the Public reiterated issues raised the Woodland Trust regarding access to Bisham Woods for residents of the village, noting that the available routes add around 25 minutes on to the journey. The resident believes that the automated barriers blocking vehicular access have been erected "by stealth" and impacts too many people.

AK asked for clarification on what is actually closed. The resident pointed out the track on the map and explained that the road is closed to vehicles. AK noted that the track in questions is designated as a footpath and closing vehicular access doesn't contravene any laws.

One Member of the Public reported that they had spoken to a number of contacts to see if there is an appetite for sponsorship of playground equipment.

GW asked for clarification as to what they would be interested in sponsoring. The resident said that sponsorship could cover capital costs and maintenance.

Colin Lemmings (CL) reported that he had attended the Flood Liaison meeting, but that the Environment Agency (EA) have no firm dates for any works to take place. The EA have been asked to organise a meeting to provide a timeframe for proposed flood works.

CL confirmed that the EA had agreed the plans to replace the Flood Warning boards.

JC asked if this was a good opportunity to look at re-siting the boards.

CL noted that the EA said the siting of the boards was at the Flood Warden's discretion.

CL reported that the new plans will specifically stipulate that the insurance for volunteers needs to be provided by the individual Parishes.
