Interpretation board – noted that this would be a larger project involving design work, and would need to be Budgeted and Planned for.

AK noted that a a more detailed board would be useful to explain the Orchard Management Strategy.

AK noted that the waste bin on the A404 layby doesn't get emptied. It was reported that the RBWM waste operatives had emptied the bin at the Snack Wagon, but left the public waste bin. AK to forward pictures to ClIrs Brar.

GW reported that there was still a water leak in Burchetts Green that had been reported to South East Water and RBWM.

DO noted that there were regular and periodic road works due to gas leaks between Stoney Ware and the Church, speculating that as each leak is repaired the relative weak point of the system migrates further along. Suggested that it may be less disruptive and cheaper to replace the whole section in one go, rather than continuously patch it.

BM presented options for the Waste Bins.

- Inspecting Tree across the lane BM noted that it hadn't been flagged as an issue by the tree surgeons
