Part One

Public Forum

One member of the Public noted that the works to the drainage culvert on the A404 had now been delayed until March. The Environment Agency has asked that designs need to be "fish friendly".

The restoration works by Cain Bio-enginerring, which were scheduled to run concurrently, will still take place in September as planned. Storage of equipment will be in the field adjacent to the playground. The work may require a Public Right of Way closure. BM noted that RBWM would need to be notified about potential PROW closures as soon as possible.

Possible Tree thinning work may be identified prior to works commencing.

Action - Cllr Brar to send PROW contact details.

Action – BM to liaise with Cain Bio-engineering for method statements, liaibility insurance, Health and Safety documentation etc.

CL noted that the initial works undertaken by Highways England has damaged the new carpark surface as heavy vehicles have been using it as a turning circle.

Action – BM to liaise with the Highways Agency to repair.

One member of the Public reported that the School Hedge was still causing an issue for pedestrians, despite the accounts showing over £500,000 in funding. In addition to the Academy funding, there has often been additional fundraising through parents and local groups. Concern that RBWM had agreed to undertake the works on the school's behalf. BM clarified that RBWM would charge the School, if they undertook the works. Cllr Brar stated that Cllr Howard had been dealing with the issue.

54. Minutes of Meeting 17th July 2023

The Council RESOLVED to approve the minutes as an accurate record of the meeting of the Council held on 17th July 2023.

55. Matters Arising

The Clerk reported that a member of the public had complained about the overgrown state of the Compleat Angler's hedge along Quarry Wood Road. It was noted that this hedge had now been pruned.

Bridge Restoration - BM reported that the contractor will provide a detailed schedule which would set out the proposed phases of the works. GW noted that at the July meeting, it had been decided to arrange for the contractor to carry out a survey of the bridge at a cost of £600 in order to enable the Council to decide the works that needed to be carried out and questioned why this had not been done. The Council needed to have reliable information on the work that was necessary and the costs involved before contracting. BM would circulate the detailed plan of works as soon as it had been received from the contractor.

GW noted that BM should notify the insurers regarding the current position, including the survey and prospective repairs to the bridge.

The Slipway - DO noted that the issue with the strakes that needed attention was that the remaining original strake was loose as the wood around the bolts had worn down. The strake itself looked to be in good order but two new bolts would be required to secure it in its proper position.

With regard to the damage caused to the surface of the Slipway near the entrance from Church Lane that had been caused by the contractors carrying out building works for the School, BM confirmed that he did not have any photos of the condition of the Slipway at the time the works were carried out or any correspondence with the School about this issue from that time. This unsatisfactory position was noted and it was agreed that BM should ask Holfords to provide a quote for levelling and re-seeding this area on the basis that the School would be responsible for the cost of the work.

Parking Space by the Playground - The contractors had carried out the work to restore and level the surface in this area but it was noted that the repaired surface had become rutted as a result of Highways England's vehicles turning on it.

Bins - BM reported that the bins had not been put in place as the bins that had been acquired were not compatible with the existing fittings. The supplier had agreed to exchange the bins and the the replacements should be delivered for installation in a matter of days.

Temple Lane TPO - BM reported that there had been no progress on this. DO noted that it was important to ensure that matters of this nature were followed-up regularly until a satisfactory response had been secured. DO agreed to draft a letter to RBWM to escalate the matter.

The Orchard - CL noted that two large branches had fallen in the Orchard and needed to be removed. He also reported that nothing had been done regarding a large tree near the footbridge and playground that was tilting badly or the apparently dead tree on The Green. BM stated that the trees on Parish Land were inspected annually and that this normally took place in the Autumn. GW expressed concern that trees are being left that are no longer viable and that the Council should deal with trees that are clearly decayed or that have suffered damage without waiting for an annual survey. JC directed BM to arrange for an arboriculturalist to inspect the three trees that had been identified and advise on the required remedial action.

The Coffin Bier - JC reported that the position regarding the Coffin Bier was unclear and BM was asked to contact Reading Museum to confirm whether it still had this item in its possession.

Defibrillator training - BM should get confirmation of the dates for the next round of Defibrillator training and report to the next Meeting. BM should also check that the batteries in the Defibrillator are still viable.

Temple Footbridge - BM reported that the Environment Agency had confirmed that the footbridge would definitely be repaired but that no indication had been given as to the time at which these works would be carried out.

Quarry Wood Road Parking - BM confirmed that there had been no response from RBWM Highways to our letter of 7 July on this matter. Similarly there had been no response regarding the overgrown vegetation on the A308 on the approach to the Bisham roundabout. BM to follow up these matters and press for a response.

Co-option to fill the Casual Vacancy - the proposed deadline for expressions of interest in this position was 8 September and BM was instructed to take the necessary steps to advertise the vacancy and inform interested parties of the procedure to be followed.

Electronic Banking - BM confirmed that the arrangements for the transfer to electronic banking were in progress and that Direct Debits could be set up by two Councillors once the new arrangements were in place.

Slate Fence at Temple - BM had nothing to report on this matter. AK's suggestion that the Council should write to Historic England regarding the state of this listed structure was agreed and BM was instructed to send a letter to Historic England.

Temple Footpath diversion - There had been no further news on this matter and it was agreed that BM should write to the RBWM's Rights of Way Officer to establish the position.

Bisham Wood - JC agreed to raise the question of spaces for cars to park at the entrance to Bisham Woods from the A308 once BM had confirmed the identity of the new responsible officer.

BPC Website - It was noted that there were several errors in the information provided on the website, including a statement that ROSPA inspections are carried out annually while the last inspection referred to was in 2016. BM to review and correct.
