80. DECLARATIONS OF INTEREST

GW reported that he had attempted to find out more about the excess waste at the Playground and had approached the manager of The Bull.

BM reported that several officers of RBWM were trying to arrange a site meeting to discuss the slate fence and footpath diversion at Temple.

CL reported that the homeless man had moved on permanently, having accepted an offer of accommodation, and that JK and another local resident had packed up his tent and belongings. CL also noted that the tent had been vandalised. JC thanked JK for their efforts.

CL noted that the spoil heap at the church has increased.

84. HIGHWAYS MATTERS

CL reported that the "school slow" sign was no longer visible on the road surface. Cllr Brar was aware and would raise with Highways.

CL reported that the gutters and gulleys had been cleared but that the surrounding leaves had not been removed, so the blockages returned quickly.

GW reported that he was too late to register to speak at the Development Control Panel and has asked for terms of reference from Democratic Services.

85. PARISH LAND

BM reported on conversations with the contractor regarding the repairs to the phone box. GW to liaise with contractor and assess suitability of solutions.

AK suggested that GW have a delegated budget of up to £300 for the door repairs.

JC seconded

Cllrs agreed.

GW gave an update on the tree works, noting that the larger ash had been removed.

JC proposed waiting until the Holdfords quote was received after 24th October before committing to further tree works.

GW seconded

Cllrs agreed.

CL noted that there was detritus remaining from previous tree works. GW believed that it was expected to rot down.

GW asked for an update about the SSEN tree works. BM still waiting for information as to when the works would be completed. CL reported that there was SSEN works planned for 6th November, which may include trees.

Cllrs asked BM to get an update on the hornets' nest from RBWM.

BM presented the quotes for the fence repairs.

JC proposed accepting the Holdfords quote.

CL seconded

Cllrs agreed

CL reported that there was evidence of a campfire on the Slipway near to one of the benches.

CL reported that there was no lock on the chain around the Slipway gate. BM to get a lock.

86. Fishing Consultation

BM reported that there had been no responses to the fishing consultation, and that it had been on the website, and in the noticeboards for a month.

Cllrs decided to move ahead with a No Fishing policy. BM to get a price for two "no fishing" signs.

87. PLAYGROUND

GW recommended getting a roofing repair on the multi play.

GW to revisit a climbing frame for the vacant plot.

88. FLOODING

CL reported that there had been nothing received from JEPU or RBWM regarding the flood strategy, and the draft was now estimated to be December. CL expressed disappointment as he was hoping to brief the marshals before this.

BM asked for clarification on the role of marshals and the collection of data for their roles. CL explained the marshals' work processes. BM to compile a list of requirements to ensure BPC is meeting requirements such as GDPR.

89. BUDGET PRE-DISSCUSSION

Cllrs discussed potential items that may affect the 26-27 budget.

GW to get costs for a Space Frame climbing apparatus.

AK stressed the need for a management plan for the Parish Land, before budgeting. JC proposed agreeing on Phase One activities ready for budget setting.

BM to get a price for replacement noticeboards.

BM noted that the finance was up to date on the website.

JC proposed providing £104 to BBRG under Section 137. GW seconded Cllrs agreed.

GW proposed setting up a Direct Debit for Holdfords. JC Seconded Cllrs agreed.
